Our Fitness Participation Program provides support to CF Community Care members in Victoria who have CF to participate in the sport of their choice and to help improve lung function and overall health.

Eligible members may be able to receive support of up to \$100 a year. Members on medium or low incomes may be eligible for additional support of 50% of the expense (up to \$150 a year or \$300 per year respectively).

How to apply

1. Complete all sections of the Fitness Participation Program application form and attach:
 - A paid tax invoice (for reimbursement), OR an unpaid invoice (for payment to club / company)
 - Proof of low or medium income if requesting additional support.

3. Applicants will be notified whether their application was successful within five business days of their application being received by CF Community Care.

Terms and conditions

You must:

- Be a 2020 member of CF Community Care
- Be a resident of Victoria (including selected NSW border towns)
- Have CF OR be the primary parent / carer of a child aged under 18 years who has CF

The Program will reimburse out-of-pocket expenses such as:

- Sporting equipment hire or purchase (e.g. treadmills, bikes, bathers, goggles, tennis racquet)
- Extra-curricular lessons (e.g. swimming lessons, horse-riding, karate, tennis)
- Gym or club membership fees (e.g. seasonal fees for basketball, football)

The Program will not reimburse expenses that:

- Have already been supported by CF Community Care, health insurance, or other services
- Are for activities/items that were not undertaken/purchased in 2020
- Are a normal school requirement
- Can be funded through other sources

If you are on low and medium income requesting additional support you must provide evidence of income (e.g. payment summary, payslip, Disability Support Pension card):

- Low income is defined as a gross (before tax) income of:
 - Less than \$45,000 a year for individuals
 - Less than \$70,000 for couples / families
- Medium income is defined as a gross (before tax) income of:
 - Between \$45,000 and \$80,000 a year for individuals
 - Between \$70,000 and \$112,000 a year for couples / families.

The support will be provided via:

- A payment made directly to the club or company - A copy of the invoice is required, OR
- Reimbursement to the applicant if activities / items have been already paid for - A copy of tax invoice is required

A completed application form must be provided

Applications for 2020 will close 1 December 2020 (or earlier if all grants have been distributed)
