 - A paid tax invoice (for reimbursement), OR an unpaid invoice (for payment to club / company)

3. Applicants will be notified whether their application was successful within five business days of their application being received by CF Community Care.

Terms and conditions

You must:

- Be a 2021 member of CF Community Care
- Be a resident of Victoria (including selected NSW border towns)
- Be the partner, primary parent/ carer or sibling of a 2020 CF Community Care member who has CF

The Program will reimburse out-of-pocket expenses such as:

- Fees for course, community group, art/movement therapy or sporting club (eg: pony club, Irish music club, ballroom dancing, choir)
- Equipment needed to participate in activity (eg: books for a book club, art equipment, riding boots, instrument hire, tap shoes)
- Travel costs to assist with attending activity (eg: fuel or public transport fares)

* We will prioritise applications of those experiencing hardship

* One application per family will be accepted each year

The Program will not reimburse expenses that:

- Have already been supported by CF Community Care, health insurance, or other services
- Are for activities/ items that were not undertaken/purchased in 2021
- Can be funded through other sources
- Are and existing activity that you are already doing (eg: continuing with a sporting club that you have been playing with since to 2020).

The support will be provided via:

- A payment made directly to the club or company - A copy of the invoice is required, OR
- Reimbursement to the applicant if activities/ items have been already paid for - A copy of tax invoice is required

A completed application form must be provided

Applications for 2021 will close 1 June 2021 (or earlier if all grants have been distributed)
